MEASURE K SUPPORTS PUBLIC SAFETY. The Encinitas Firefighters Association endorses this measure because they know it is vital for maintaining and improving public safety services.

MEASURE K IS CRUCIAL FOR INFRASTRUCTURE. Endorsed by the San Diego County Taxpayers Association, Measure K is a responsible solution to fund infrastructure projects like road repairs, railroad crossings and access to public spaces.

MEASURE K FUNDS LONG OVERDUE, URGENT PROJECTS. It is very necessary to have the revenue needed to address a 2012 Grand Jury report on the lack of adequate storm water facilities in Leucadia; Measure K will do that so the projects can be completed in a responsible way.

MEASURE K IS THE RESPONSIBLE APPROACH. Groceries, medical services and prescriptions are exempt from sales tax. The resident-led Infrastructure Task Force unanimously recommended this approach.

MEASURE K HAS ACCOUNTABILITY. Stringent oversight measures include an independent citizens' committee ensuring funds are spent as promised, safeguarding transparency. It is NOT a blank check.

MEASURE K ENSURES VISITORS WILL PAY THEIR SHARE. A significant portion of the annual sales tax revenue will be paid by visitors to our city, meaning tourists will pay for the costs of maintaining our city.

MEASURE K IS TEMPORARY. This tax has a fixed 10-year term. Any extension will require voter approval, ensuring continued accountability.
