The items listed in the table below summarize the required submittal materials for a substantial conformance request.

All submittal items shall be provided in digital portable document format (PDF), meet the City's Document Submission Standards/File Category and be named in accordance with the required File Naming Conventions. 2. Substantial Conformance Determination ^{1,2}
A. Proposed Extension Request Scope:
Memorialize minor changes being made to a previously approved project.
Required intake appointment items:

 Written statement summarizing the proposed minor changes to the approved project and a written discussion/justification of the reason for the changes

FOOTNOTES:

¹If the project requires other discretionary application types (coastal development permit, design review permit, etc.) and the intake submittal requirements overlap, only one of the duplicate submittal items is required for the project submittal.

²The findings for a substantial conformance request differ by application type. For coastal development permits see Encinitas Municipal Code (EMC) Section 30.80.130, for use permits see EMC Section 30.74.105, and for design review permits see EMC Section 23.08.140. If the modifications being made to a project require any changes to the original conditions of approval, a substantial conformance cannot be granted. When this occurs, the project must apply for a use permit modification or design review permit modification.
