NOTICE IS HERBY GIVEN THAT:

1. All work on Project No. CW23X: Air Valve and Blow Off Replacement Project Phase 1 located on Encinitas Blvd, Rancho Santa Fe Road, and El Camino Del Norte ceased on **September 11, 2024**.
2. Such cessation of work continued from that date to the date of recording of this Notice of Cessation.
3. The construction began on March 6, 2024 pursuant to the AGREEMENT between the San Dieguito Water District, an Irrigation District of the State of California and M-Rae Engineering, Inc., a California corporation, dated January 18, 2024.
4. The San Diego Water District is the OWNER of the public improvements and is located at 160 Calle Magdalena, Encinitas, CA 92024.
5. M-Rae Engineering, Inc. is the CONTRACTOR and is located at 9865 Meadow Lane Descanso, CA 91916.
6. The Agreement included "the removal and replacement of ten (10) Air Release Valves and six (6) Blow Off assemblies and appurtenances, paving, and traffic striping".
