## **PLEASE NOTE:**

- ADUS OVER 500 SF REQUIRE A GEOTECHNCIAL REPORT. ADDITIONAL SITE SPECIFIC CONDITIONS MAY ALSO REQUIRE A NEED FOR A GEOTECHNICAL REPORT PER THE REQUEST OF THE CITY'S GEOTECHNICAL CONSULTANT.
- **2.** GEOTECHNICAL REPORTS SHALL ADDRESS AND PROVIDE ALL INFORMATION AS REQUIRED IN 23.24.170 AND 23.24.180 OF THE CITY OF ENCINITAS MUNICPAL CODE.
- **3.** EARTHWORK QUANTITIES OF 50 CUBIC YARDS OR GREATER SHALL REQUIRE A GRADING PERMIT PER THE CITY OF ENCINITAS MUNICIPAL CODE 23.24.090. REFER TO 23.24.090 FOR ALL GENERAL EXEMPTIONS.
- **4.** FOR PROPERTIES SERVICED BY SEPTIC SYSTEMS, A SEPTIC LAYOUT APPROVAL FROM THE COUNTY OF SAN DIEGO DEPARTMENT OF ENVIRONMENTAL HEALTH AND QUALITY IS REQUIRED.
- 5. ALL WORK WITHIN THE PUBLIC RIGHT OF WAY REQUIRES A RIGHT OF WAY PERMIT.
