RESOLUTION NO. 2024-85

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ENCINITAS, CALIFORNIA, TO AUTHORIZE SUBMITTAL OF THE LOCAL COASTAL PROGRAM AMENDMENTS TO SECTION 30.84.010 OF CHAPTER 30.84 (SPECIFIC PLANS) OF THE ZONING REGULATIONS AND FIGURE 4 LAND USE POLICY: NEW ENCINITAS MAP OF THE LAND USE ELEMENT OF THE GENERAL PLAN TO THE CALIFORNIA COASTAL COMMISSION

WHEREAS, the City of Encinitas City Council, after giving notice as prescribed by law, held a public meeting on September 11, 2024, to consider adoption and approval of the El Camino Real Specific Plan and related amendments to the Zoning Regulations and General Plan; and

WHEREAS, on September 11, 2024, the City Council adopted Resolution No. 2024-83 adopting a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program and Resolution No. 2024-84 amending Figure 4 Land Use Policy: New Encinitas Map of the Land Use Element of the General Plan, and introduced Ordinance No. 2024-08 to amend Section 30.84.010 of Chapter 30.84 (Specific Plans) of the Zoning Regulations and to adopt the El Camino Real Specific Plan; and

WHEREAS, the Zoning Regulations and Figure 4 Land Use Policy: New Encinitas Map of the General Plan are components of the City's Local Coastal Program (LCP); therefore, the amendments constitute amendments to the Local Coastal Program; and

WHEREAS, a Public Notice of Availability of proposed Local Coastal Program Amendments (LCPA) was issued which opened a six-week public review period that ran from July 26, 2024 through September 6, 2024; and

WHEREAS, the City Council intends to implement the Local Coastal Program in a manner fully consistent with the California Coastal Act.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Encinitas, California, that:

Section 1. The recitals above are each incorporated by reference and adopted as findings by the City Council.

Section 2. The City Council finds that the proposed amendments are consistent with the Certified Encinitas Local Coastal Program and Chapter 6 of the Coastal Act, and are intended to be carried out in a manner in full conformance with the California Coastal Act of 1976.

Section 3. The California Coastal Commission is hereby requested to consider, approve and certify the Local Coastal Program Amendment.

Section 4. Pursuant to Section 13551(b) of the Coastal Commission Regulations, the Local Coastal Program Amendment will take effect automatically upon Coastal Commission approval, as provided in Public Resources Code Sections 30512, 30513 and 30519.

Section 5. This resolution shall become effective upon the second reading and City Council adoption of Ordinance No. 2024-08.
