I write as an Encinitan with a lifelong disability.

While you embark on exploration(s) of where to place affordable housing in Encinitas I implore you to insist upon a significant number of units in every project considered to include ADA compliant apartments and/or units for persons with disabilities. These should not only include ambulatory limitations, but also, sighted and hearing disabilities as well.

The notion that persons with disabilities should walk or crutch or push their wheelchair 1/2 mile from public transportation is mean and untenable. Kindly keep this in mind for all planning purposes.

Finally, consistent with my years of advocating for low and moderate income housing throughout Encinitas, I am against concentrations of low & moderate income housing in projects as they cause stigma and violate notions of inclusion and fairness

The remedy as voted by our community two times by rejecting Measures T & U as inadequate, is to mandate 20% low & moderate housing (including ADA units) into every project over three units.
