The farm is located at 3563 Fortuna Ranch Road, Olivenhain, in the RR Zone, bordering the City of Encinitas and the County of San Diego. The land measures 2.56 acres. Sugar Sweet Farm aims to establish a sustainable space for residents to participate in gardening, keeping small animals, and selling fresh produce. The initiative aims to strengthen community ties, encourage environmental stewardship, and improve food security while providing educational opportunities for all age groups. This application is a response to a permitting requirement that arose while we were already engaged in these activities. It formalizes what has happened for the past 20 years; it does not involve new use or property improvements.
