## Bus Tour Schedule

- On Thursday, September 22, 2016 to begin and end in the parking lot of City Hall, located at 505 S. Vulcan Avenue, Encinitas CA 92024. 8:00 AM – 11:00 AM
  - 8:00 AM – Load the bus to tour various locations in the City of San Clemente - visiting one or more At-Grade crossings to experience the crossing(s) and a Wayside Horn(s). Coastal Mobility and Livability Working Group members will interact with city staff, make general observations, and possibly discuss project-related issues or concerns. This is an informational bus tour visit, which proceeds a Wayside Horn Test Demonstration, scheduled for the same day (September 22<sup>nd</sup> near the Montgomery Avenue and San Elijo intersection from 5:30 PM – 6:30 PM). No deliberations of At-Grade crossings or Wayside Horns will be made during the tour or at the demonstration event. A future meeting in November 2016 will be devoted to receiving public input on the Montgomery Avenue crossing, crossing alternatives, and Wayside Horn device.
