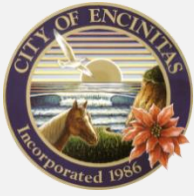


An organization's group and percentage of resident participation determines their field allocation. Priority also given to primary season sport and historical use.

2	<p>Resident Youth Recreational Sports Nonprofit, Non-competitive Priority allocation for this group is based on the percentage of resident participation in each league as follows:</p> <ul style="list-style-type: none"> I. Top Priority: 70% or more residents II. Next Priority: 40%-69% residents III. Last Priority: less than 40% residents. <p>Organizations must meet all the following criteria:</p> <ol style="list-style-type: none"> 1. Organizations must be recreational play and have an “everyone plays, no child is turned away” philosophy requiring that each player suited-up and able to play is entered into games for a significant period of time (i.e. ½ of game or 2 of every 5 innings or 2 of 4 quarters, etc.); and 2. Organizations must submit a Letter of Determination or Letter of Affirmation from the IRS that indicates a non-profit 501(c)(3) status certificate; and 3. Organizations must maintain an affiliation with a national, state, or local sport governing body. Those national or state bodies must have governance over the organization, including all requirements for training per each league’s manual, background checks and disciplinary actions; and 4. Organizations have an existing, functioning entity within its own governing body (i.e. board of directors or trustees) with By-laws and Articles of Incorporation; and 5. Each organization is responsible for appointing an individual to be the field coordinator for the organization.
3	<p>Resident Youth Competitive Sports Nonprofit Priority allocation for this group is based on the percentage of resident participation in each league as follows:</p> <ul style="list-style-type: none"> I. Top Priority: 70% or more residents II. Next Priority: 40%-69% residents III. Last Priority: less than 40% residents. <p>z Organizations that must otherwise meet all Group 2 requirements EXCEPT one of the following:</p> <ol style="list-style-type: none"> 1. They hold tryouts in order to place registrants according to their ability on competitive teams (select, travel, etc.); applicants may be turned away; or not every player suited up and not able to play in every game, or 2. Provide compensation for local executive/administrative staff, coaches, and/or board members for their service to the league.

5	Resident Adult Groups – Recreational
6	Resident Adult Groups – Private
7	Resident Adult Groups – Profit Making
8	Non-Resident Groups

- Group 2, 3 permit fees are due before the end of the allocation season, June 15 or December 15.
- Group 2, 3 Leagues with players on both recreational and competitive teams will only pay once per allocation at the competitive rate.
- Group 4 – 8 permit fees are due when the permit is confirmed and signed.
- Pass-through of credit/debit card transaction fees and pass-through of recreation software fees will apply.
- Athletic field fees will be reviewed annually.
